

- xt. That the accounts of the Institution shall be audited providing by a certified Chartered Accountant and shall be open for Inspection by the Council or any body or person authorized by K.
 - (a) Dean/Associate Director: A taxify member at the level of Professor may be identified and appointed from the relevant field as Dean/Associate Director for each Faculty/School.
 - (b) Faculty: The Faculty should be available in each institution as per the existing norms.

- (c) Non-Teaching staff: The Non Teaching staff should be available as per the existing norms in each institution. A Registrar/Chief Administrative Officer should be appointed to look after administrative ectivities of the entire campus. A placement officer should also be appointed to look after the placement activities of all the Institutions located in the Campus.
- (d) Other Campus factities: A common Canteen, common Sports facility and Auditorium etc. may be developed in the Campus for the benefit of atudents of all the Institutions located in the Campus
- (a) That all the aboratories, workshope etc. shall be equipped as per the syliabil of the concerned affiliating University University under whose ambit the institution is functioning, and shall be in operational condition before making admissions.

(f) A Central Library covering all the subjects of various institutions located at the same campus with separate libraries located in respective institution/departments is required to be provided. The total no of books, volumes and journals should be the sum of all the requirement of department/institutions logether as per AICTE norms.

- (2) A Centrel Computer Center for various institutions located at the same computer with departmental/institutional computer centers located in respective institutions/departments is required to be provided. The no of computers required are rationalized and the computer student ratio be released up to 1:6 adequate number of lerminals, Printers, legal software etc. shall be established as per AICTE norms.
- That the institution shall furnish requisite returns and reports as desired by AICTE in order to ensure proper maintenance of administrative and scademic standards.
- (XV) That the technical institution shall publish an information bookket before commencement of the reademic year giving details regarding the institution and bourses/programmes being conducted and details of infrestructural facilities including faculty etc. In the form of mandatory disclosure. The information bookket may be made evailable to the stakeholders of the technical education on cost basis.
- (xv) That it shall be mandatory for the technical institution to maintain a web-sits providing the prescribed information. The web-site information must be continuously updated as and when changes take piece.
- (xvl) That a compliance report in the prescribed formal sleng with mandatory disclosure on fulfiliment of the above conditions, shall be submitted each year by the Institution within the time limit prescribed by the Council
- (xvii) That if Technical Institution fails to disclose the Information or suppress and/or misrepresent the information, appropriate action could be initiated including withdrawal of AICTE approval.
- (will) That a Joint FDR is required to be created for an amount and period prevented by the Council separately for each institute from time to time.
- (XIX) AICTE may carry out random inspections round the year for verifying the status of the institutions to ensure maintenance of normo and standards.
- (xx) That the AIGTE may also conduct inspections with or without notifying the dates to variely specific complaints of misrepresentation, violation of norms and standards, mat-practices ato.
- (xx) That the institution by virtue of the approval given by Council chall not automatically become claimant to any grant-in-aid from the Central or State Government.
- (xxii) The Institute shall take appropriate measures for prevention of regging in any form, in the light of directions of Supreme Court of India in Writ Petition No. © 656/1998, these of feiture to prevent the instances of ragging by the Institutions, the Council shall take appropriate action including withdrawal of approval.
- (xxlii) That the Management shall strictly follow further conditions as may be specified by the Council from time to time
